



## Synopsys, Inc. CoPilot Terms of Use

### I. Your Agreement With Us

Synopsys, Inc. ("Synopsys") permits access to and use of the CoPilot tool (the "Service") subject to these terms and conditions (the "Terms"). PLEASE READ THESE TERMS CAREFULLY.
